WAIVER AND RELEASE OF LIABILITY

IN CONSIDERATION OF BEING ALLOWED TO PARTICIPATE IN ANY WAY IN THE PDXLAN LAN EVENT AT THE HOLIDAY INN PORTLAND AIRPORT CONFERENCE CENTER AND RELATED EVENTS AND ACTIVITIES, THE UNDERSIGNED:

1. AGREES THAT IF UNDER 18 THE PARENT(S) AND/OR LEGAL GUARDIANS(S) WILL INSTRUCT THE MINOR PARTICIPANT THAT PRIOR TO PARTICIPATING HE OR SHE SHOULD INSPECT THE FACILITIES AND EQUIPMENT TO BE USED, AND IF THE PARTICIPANT BELIEVES ANYTHING IS UNSAFE, HE OR SHE SHOULD IMMEDIATELY ADVISE A PDXLAN STAFF MEMBER AND REFUSE TO PARTICIPATE.
2. ACKNOWLEDGES AND FULLY UNDERSTANDS THAT EACH PARTICIPANT WILL BE ENGAGING IN ACTIVITIES AND CONTESTS THAT MAY INVOLVE RISK OF SERIOUS INJURY TO THEIR PERSON AND TO COMPUTERS AND ELECTRONICS, INCLUDING VIRUSES, POWER FAILURE AND SEVERE SOCIAL AND ECONOMIC LOSSES WHICH MIGHT RESULT NOT ONLY FROM THEIR OWN ACTIONS, INACTIONS OR NEGLIGENCE, BUT THE ACTION, INACTION OR NEGLIGENCE OF OTHERS, OR THE CONDITION OF THE PREMISES OR OF ANY EQUIPMENT USED. FURTHER, THAT THERE MAY BE OTHER RISKS NOT KNOWN TO US OR NOT REASONABLY FORESEEABLE AT THIS TIME.
3. ASSUMES ALL THE FOREGOING RISKS AND ACCEPT PERSONAL RESPONSIBILITY FOR THE DAMAGES FOLLOWING SUCH DAMAGE, PERMANENT OR TEMPORARY.
